124th Legislative Session (2020-22)



Trident United Way (TUW) endeavors to become a nonprofit policy leader as one way of supporting measurable community change. TUW remains non-ideological and non-partisan in its advocacy, urging lawmakers to set aside partisanship and to work together. TUW uses its convening power—bringing together all its partners: business, labor, nonprofits, and advocates—to help find policy common ground and to create change.

We recognize that state and local policy structures have led to systemic inequities based on race. African American students, even those not in poverty, are 25% less likely to read at grade level than students in poverty and over 200% less likely than their White Non-Hispanic peers; African Americans and Hispanics are between two and six times more likely to report being uninsured than their White Non-Hispanic peers, and are almost three times more likely to be in poverty<sup>1</sup>. We believe that one's prospects should not be tied to their race, zip code or their initial station in life and that policy solutions should work to address these systemic inequities.

#### **EDUCATION**

Improve educational outcomes for all students in the Tri-County region.

- Every child will be prepared for school and to meet grade level standards
- Every child will be supported in and out of school
- Every child will graduate from high school prepared for employment in the modern workforce or to achieve a postsecondary degree or credential
- All families will be engaged in their child's learning and development

#### **FINANCIAL STABILITY**

Improve the standard of living for all individuals in the Tri-County region.

- All individuals who need them will have access to supports necessary to overcome financial crisis and move into financial stability
- All individuals who need them will have access to work supports necessary to achieve greater financial stability through gainful employment
- All individuals will know how to gain and sustain the assets necessary to maintain financially stable lives

#### **HEALTH**

Improve the health of all individuals in the Tri-County region.

- All individuals will have access to health care
- All individuals will have an opportunity to live and participate in social and physical environments that promote good health
- All individuals will know how to lead healthy lives
